Greetings to all Seven Oaks Homeowner's:

Recent Updates:

- ❖ Hail Damage Update. A severe Hail storm impacted the Wyomissing area on Thursday, May 22, 2014 @ 3:00 PM with 70 mile per hour winds and golf and tennis ball size hail. The HOA has filed a claim with its insurance company to assess the buildings, vinyl siding, roofs, gutters, downspouts, flashing, dumpster enclosures, etc. The property adjuster was on site Thursday, May 29, 2014 ó one week after the hail storm. The process with take some time, so we are asking all Unit owners to please be patient. As a matter of record, the HOA has a \$10,000 deductible.
- As information becomes available, we will be providing periodic updates on the status of repairs. The good news is that the buildings are all water tight and the damage is not catastrophic.
- ❖ If any Unit owners have damage to their particular units from the hail storm, it is recommended that you notify your <u>personal</u> insurance company and get a claim started under your <u>personal</u> insurance policy.

- ❖ There was widespread damage to many screens and windows at Seven Oaks. The HOA is looking into contracting with one window contractor to replace all broken and damaged screens. Unit owners can hire their own window contractor to immediately take care of their screens and windows or wait until we can have a single contractor take care of the entire development. Once we have pricing, we will pass along to Unit Owners for consideration.
